## UNIQUE HERITAGE MEDIA ANNOUNCES A €8.5 MILLION FUNDRAISING TO FINANCE AND EXPAND ITS GROWTH

UNIQUE HERITAGE MEDIA (UHM), a media and publishing company specialized in creating content for young people and their families, has announced a €8.5 million fundraising through a capital increase from its historical shareholders Entrepreneur Venture and 123 Investment Managers and through a private debt funding carried out by the alternative asset management and investment group Tikehau Capital. After the acquisition of Disney Hachette Presse, Education Wizards Investissement, an investment holding company specialized in education led by Emmanuel Mounier, remains UHM's majority shareholder.

The main purpose of this fundraising is to help UNIQUE HERITAGE MEDIA accelerate its growth in the publishing, media and ICT sectors targetting young people and their families; it has mainly enabled the group to acquire Disney Hachette Presse.

"I'm pleased to welcome Tikehau Capital in this new funding round, alongside Entrepreneur Venture and 123 Investment Managers which have been faithfully supporting us since 2015 and 2018. Thanks to our financial partners, I wish to make UNIQUE HERITAGE MEDIA a French renowned edutainment company whilst developing a creative and innovative key player of the European education and youth media industries", said **Emmanuel Mounier**, CEO of Unique Heritage Media.

Tikehau Capital, which joined the other funds for this new funding round of €4.5 million as a private debt investor, invests through its funds Novi1 and Groupama Tikehau Diversified debt Fund.

"Through this financing, we are happy to take part in the development of an SME known for its strategic and operational excellence and to give Unique Heritage Media's management team the opportunity to become a French leading edutainment company", said Nathalie Bleuven, Head of the Tikehau Capital Corporate Lending activites.

"After participating in the taking over of Fleurus Presse, we will keep supporting the management team in its build-up strategy, in which Disney Hachette Presse appears as a key milestone. In that way, the Group will be able to become one of France's leading edutainment companies," said **Bertrand Folliet**, Entrepreneur Venture.
